BYLAW NO. 5-2015**


**A BYLAW TO PROVIDE FOR PUBLIC DISCLOSURE BY MEMBERS OF
COUNCIL**

WHEREAS it is deemed in the public interest to provide for public disclosure by members of Council;

NOW THEREFORE the Council of the RM of Manitou Lake No 442, in the Province of Saskatchewan, enacts as follows:


1. This Bylaw may be cited as "The Public Disclosure Bylaw."
2. Pursuant to Section 142 of *The Municipalities Act*, every member of Council must file a public disclosure statement with the Chief Administrative Officer within thirty days of being elected.
3. Every public disclosure statement must be in the form attached to and forming part of this Bylaw and must contain:
 - a) The name of:
 - (i) The employer of the member of Council, if any;
 - (ii) Each corporation in which the member or someone in the member's family has a controlling interest, or of which the member or family member is a director or senior partner; and
 - (iii) Each partnership or firm of which the member of Council is a member; and
 - b) The municipal address or legal description of any property located in the municipality or adjoining municipality that:
 - (i) The member of Council or his or her spouse owns; or
 - (ii) Is owned by a corporation, incorporated or continued pursuant to *The Business Corporations Act* or *The Canadian Business Corporations Act*, of which the member or his or her spouse is a director or senior officer or in which the member or his or her spouse has a controlling interest.
4. Every member of Council who has previously filed a public disclosure statement must annually submit a declaration that either declares that no material change has occurred since the last public disclosure statement was filed, or details the material changes that have occurred since the last public disclosure statement was filed.
5. The annual declaration as outlined in Section 4 of this Bylaw must be submitted by November 30th of each year.
6. The Chief Administrative Officer shall ensure that each public disclosure statement and each declaration is available for public inspection during normal business hours.
7. This Bylaw shall come into force and take effect upon third reading thereof.
